

## Basic Crime Scene & Evidence Photography Workshop For the Incident Scene Investigator

### Carpentersville Police Department (IL)

May 20 – 22, 2024

This is a three day (24 hour) hands-on workshop designed to develop the forensic photography and scene documentation skills of the incident scene investigator. It presents detailed instruction in fundamental photographic principles and exposure to useful photographic accessories. The approach to, and basic techniques used in documenting crime and other incident scenes are introduced.

Persons interested in attending will be required to bring photography equipment.

The registration fee includes all materials used in the class including photo processing.

The small class size of this workshop is meant to allow students ample time to work through practical exercises and to permit the instructors to closely evaluate each student's work.

Upon receipt of the registration form, a confirmation notice will be sent including directions to the class site and a list of equipment that the student will need to bring.
